Obstetrician/gynecologists should be taught to recognize symptoms, warning signs of AIDS, and suggest to at-risk patients that they be tested. Curriculum should also include the ethical responsibility to treat AIDS patients.
 - (b) Increase the number of research projects conducted specifically on HIV/AIDS and women. Specific topics to be explored should include: birth control pills and how they interact with the progression of AIDS, T-Cell count gender differences and any requisite

effect this may have on appropriate medicine dosages for women.

- (c) Make specific efforts to increase participation of women, particularly minority women, in clinical trials of drug treatments. UC should start clinical drug trials specific to women, and determine appropriate dosages of medicine other than AZT.
- (d) Explore ways to urgently expand effective public education, including mass media campaigns, and school and college-based educational programs. The public segments of higher education and private colleges and universities receiving state financial assistance are urged to adopt systematic AIDS education and prevention programs, and to set the urgent goal of making AIDS awareness a mandatory outcome of a college education. To the extent possible, these institutions should also provide confidential HIV testing and counseling services.
