

Major Differences in LCFFs for School Districts:



Assembly. Largely built upon Governor's proposal with three main differences: (1) increases target base rates, (2) uses duplicated EL and LI student counts, and (3) at full implementation, funds districts at the higher of their LCFF target or economic recovery target (assumes revenue limit deficit factor retired, categorical cuts restored, and future cost-of-living adjustments provided). Has simpler fiscal accountability provisions than Governor and modifies academic accountability provisions.

Senate. Largely built upon Governor's proposal but has four main differences: (1) delays implementation until 2014-15, (2) increases base rates (about \$500 above Governor's base rates), (3) increases EL/LI supplemental rate, and (4) does not include concentration funding. Has simpler fiscal accountability provisions than Governor but adopts similar academic accountability provisions.

Average Target Base Rate ^a	\$7,378	Sets base rates \$500 above Governor's proposed target base rates.
EL/LI Supplement	35% of base rate	Adopts Governor's proposed rate.
Concentration Funding	35% of base rate	Adopts Governor's proposed rate.
Concentration Threshold	75% EL/LI students	Provides additional resources to districts with disproportionate concentrations of EL/LI students.
EL/LI Count	Unduplicated	Adopts Governor's proposal to limit supplemental funding for EL-only students to seven years.
CSR Adjustment	11.2% of K-3 base rate	Requires districts to keep K-3 class sizes at 24:1 or lower.
CTE Adjustment	2.8% of high school base rate	Requires districts to use CTE adjustment for career and college readiness. Requires districts with ROCPs to maintain programs for one transitional year.
Add-ons ^b	TIIBG, HTS Transportation	Includes BBL requiring study to identify ways to restructure HTS Transportation program. Maintains spending restrictions for HTS Transportation.
Economic Recovery Target (ERT)	Funds LCFF target or ERT, whichever is higher	The ERT retires revenue limit deficit factor, increases categorical funding to 2007-08 level, and applies COLA moving forward (except for districts with exceptionally high per-pupil rates).
Fiscal Accountability	Includes general, overarching parameters	Requires districts to use EL/LI supplement and concentration funding to supplement, not supplant, other resources.
Academic Accountability	Adopts principles paralleling current FCMAT system	Phases in components of new system over several years. Increases interventions as problems become more serious. Uses regional accountability system. Establishes new agency to support districts' improvement efforts.
