Office of Emergency Services (OES) Has Many Responsibilities Related to Disasters

- Planning. Prepares the state's Hazard Mitigation Plan and Emergency Plan. Coordinates and supports other state and local disaster planning activities.
- Communications. Facilitates emergency warnings and public safety communications during disasters and other emergencies by supporting the earthquake early warning system, 9-1-1 system, and public safety radio system.
- Response and Recovery. Monitors and coordinates disaster response and recovery activities, including tasking other agencies with carrying out specific activities and coordinating mutual aid.
- Administration of Disaster Assistance Funding. Serves as a conduit for disaster assistance to state and local governments.
 - State Funding. Administers the California Disaster Assistance Act (CDAA) program, which funds the repair of public infrastructure and reimbursements to local governments for costs associated with certain disaster response activities.
 - Federal Funding. Administers federal funding provided to state and local governments in the event of a large-scale disaster that triggers a federal disaster declaration. This assistance includes reimbursements for activities such as fire response, debris removal, and rebuilding of public infrastructure. The federal government also operates the Hazard Mitigation Grant (HMG) program, which funds projects that reduce the likelihood and severity of future disasters. (The federal government also has various programs that assist individuals and businesses.) Typically, the federal government covers 75 percent of eligible costs, and state and local governments pay the remaining 25 percent. However, cost shares can vary.

Governor's 2019-20 Disaster and Emergency-Related Budget Proposals for OES

\$30 Million in 2018-19—Chapter 1, Statutes of 2019 (AB 72, Committee on Budget)

- Public Education (\$20 Million). General Fund support for grants to local entities to conduct a public education campaign on disaster-preparedness.
- 9-1-1 System and Broadband Network (\$10 Million). Loan from the General Fund to the State Emergency Telephone Number Account (SETNA) to support the 9-1-1 system and its upgrade to a system known as Next Generation 9-1-1.

\$183 Million in 2019-20

- Federal Trust Fund Authority Increase (\$60 Million). Increased Federal Trust Fund authority in 2019-20 and ongoing to accept federal funds for the HMG program.
- 9-1-1 System and Broadband Network (\$51 Million). \$50 million in 2019-20 from the General Fund to SETNA for continued support Next Generation 9-1-1, and \$1 million from SETNA in 2019-20 and ongoing to coordinate implementation of the First Responder Network Authority broadband network.
- Mutual Aid Engines (\$25 Million). General Fund support in 2019-20 and ongoing to preposition mutual aid fire engines when fire risks are high.
- **CDAA (\$20 Million).** General Fund augmentation in 2019-20 for CDAA.
- Earthquake Early Warning (\$16 Million). General Fund support in 2019-20 to complete the build-out of the state's earthquake early warning system.
- Public Safety Radios (\$11 Million). General Fund support for improvements to the public safety radio system. (Under the proposal, funding would increase to \$12 million annually from 2020-21 through 2023-24, then decline to \$3 million annually thereafter.)
